### Narrative

On 3-13-07 at approximately 0211 hours, I was on patrol, in a fully marked Scottsdale Police vehicle shop 1911, and was wearing the standard SPD tan patrol uniform. At this time I was driving westbound on E. Osborn Rd. As I approached N. 64th St, I observed a gray sedan traveling slowly southbound on N. 64th St, make a U-turn, and continue northbound.

I turned right (north), and observed the vehicle stop at a red light at N. 64th St, then turn right against the red light eastbound onto E. Indian School Rd. At this location there are two signs clearly posted stating NO RIGHT ON RED: one located on the east side of the road facing southbound traffic, and one posted next to the far/overhead traffic signal facing southbound traffic. Traffic conditions were very light at this time. I turned right (eastbound) following the vehicle, and saw only the gray Chrysler on the road, I followed the vehicle, catching up to the vehicle, a gray Chrysler 300, AZ 262WYS, at approximately 6700 E. Indian School Rd. There were no other vehicles between myself and the Chrysler. I maintained visual contact with the vehicle from the time I observed the red light violation.

At approximately 7400 E. Indian School, I observed the vehicle driving east in the curb lane of Indian School Rd, drift over the lane marker approximately six inches for a duration of approximately two seconds, then drift back into the curb lane. The Chrysler did this three times between 7400 E. Indian School Rd and 8100 E. Indian School Rd. Upon passing Miller Rd (7600 E), the vehicle slowed abruptly to approximately 25 miles per hour, then would speed up to up to 45 miles per hour and then slow down. The Chrysler did this three times between 7600, and 8100 E. Indian School. I had to abruptly press on my brakes while following the Chrysler. One unrelated vehicle, traveling eastbound in the median lane had to swerve slightly to the left to avoid the Chrysler at approximately 7800 E. Indian School. The vehicle ultimately slowed and abruptly turned right (south) onto 81st St without activating a turn signal. At this time, I initiated a traffic stop by activating my overhead lights. The vehicle pulled to the side of the road at 4032 N. 81st St.

The vehicle was occupied by a lone male subject, later identified by a Washington State DL as Jerramy Ryan Stevens. As I contacted Jerramy I observed he was not wearing a seat belt. Upon contact with I immediately smelled the odor of an intoxicating beverage from the inside of the vehicle. eyes were bloodshot and watery, and half closed. spoke with , slow, slurred speech. I asked for his license, registration and insurance. fumbled with his wallet, and paperwork from the glove box.

I asked what he had to drink tonight. told me he had "a little". I asked what a little meant. He stated "four or five margaritas at Salty Senorita in downtown Scottsdale. to exit the vehicle. He agreed. As exited the truck, he dropped his cell phone and wallet on the ground, bent down to pick them up, then stutter-stepped as he started to walk in my direction, leaving the drivers side

We walked to the sidewalk on the , where I performed the HGN test on Jerramy, and I saw six distinct and sustained clues of nystagmus. While outside the vehicle, I continued to smell the odor of an intoxicating beverage coming from breath. I told I was conducting a DUI investigation. swayed front to back, and side to side, approximately 1 inch while he stood. agreed to perform Standard Field Sobriety Tests (SFSTs). (Please see Scottsdale Alcohol Influence Report for results.) However after the walk and turn, he refused further tests, including taking a portable breath test (PBT).

At approximately 0225 hours I arrested Jerramy for DUI. I handcuffed Jerramy; hands double locked to the rear, searched his person. In Jerramy's rear left pants pocket, was a bunch of white paper napkins with a loose clump of a green leafy substance. and placed him in the rear of my patrol car. At 0214 hours I read the Admin Per Se/Implied Consent affidavit. stated he would submit to the specified tests. At 0502 hours I witnessed SPD contract phlebotomist Ethan draw two vials of blood from Jerramys right arm. While stated, I transported Fred to district one jail for booking. At 0508 hours I read his Miranda Rights. When asked if he understood these rights, he stated, "Yes sir." stated he did not wish to answer any further questions.

Using citation number 1693832, I cited for the following:

"DUI- Alcohol; ARS 28-1381.A1,

"BAC .08 or Above Within Two Hours of Driving; ARS 28-1381.A2, and

"Speed; ARS 28-701.E.

was booked and bonded out (out of state), pending a Scottsdale City court date of 4-2-07.

At 0600 hours I impounded the blood kit at District One as evidence.

This concludes my involvement in this matter.

### Narrative

On 3/13/07 at about 0213 hrs I was dispatched to back-up Officer Jones on a traffic stop in the 4000 blk of 81st St.

On arrival I found Officer Jones parked behind a gray Chrysler 4D sedan. Officer Jones told me that he had been following the car since 64th St/Indian School where he observed it make an illegal right turn on red. Officer Jones said that when he contacted the driver, later identified as Jerramy Stevens, he had smelled the odor of an alcoholic beverage on his breath and asked that I stand by while he conducted a DUI investigation.

While Officer Jones re-contacted Stevens, I took a position on the west sidewalk of 81st St to act as Officer Jones' cover officer. Officer Jones then had Stevens walk over to the west sidewalk where I was located to have him perform the SFSTs. While Officer Jones explained and demonstrated the Walk and Turn test, I used my flashlight to illuminate Officer Jones and the testing area. When it was time for Stevens to do the Walk and Turn, I saw him start in the middle of the sidewalk and as he began to walk he staggered heavily to his left and ended up off of the sidewalk and in a driveway where he stumbled and almost fell down. When it came time for Stevens to walk back to the starting position he declined to do any further testing. At that time Officer Jones placed Stevens under arrest for DUI.

Officer Jones then walked Stevens to rear of his patrol car and began to search Stevens. As Officer Jones was taking items out of Stevens left rear pants pocket I observed him remove a small handful of a green leafy substance that based on my training and experience I believed to be marijuana. This was placed in a separate plastic bag from the rest of Stevens' property.

Once Stevens had been placed in the back of Officer Jones' patrol car, I assisted Officer Jones with a search of Stevens' vehicle prior to it being impounded. When I opened the driver's front door and leaned in I smelled the strong odor of marijuana. As I continued searching the driver's area I was able to determine that the smell was coming from the driver's seat itself, which was consistent with sitting in the seat on top of unpackaged marijuana. No contraband was found in the car and it was impounded by All City Towing.

While waiting for the tow truck to arrive I saw Officer Jones read Stevens the admin per se form. After several minutes Officer Jones notified me that Stevens had refused to take a blood test. Officer Jones then asked that I meet him at the District 1 jail to assist with obtaining a TSW if needed.

After turning Stevens' car over to the tow company I responded to the District 1 jail. At the jail Officer Jones again read Stevens the admin per se form and again Stevens refused to take the blood test. Officer Jones then served Stevens with his one year suspension. After this I read Stevens the SPD standard TSW policy statement from a pre-printed supplement form. Stevens stated, "I understand" and nothing else. I then completed the affidavit for a TSW and faxed it to
